### **Request to refrain from unnecessary entry to the hospital areas**

Due to the rapid spread of COVID-19 infection, undergraduate and graduate students (non-medical personnel) are requested to refrain from entering the hospital areas as follows in order to minimize contacts between medical personnel and non-medical personnel (undergraduate and graduate students).

#### **1. Restrictions on unnecessary entry to the hospital areas**

Period: Effective today (August 3, 2020) for the time being

Areas: Hospital premises (including stores, coffee shops, food court/cafeteria, outpatient waiting room, central pathway), shown in the Annex attached to this notification

\*Please, also refrain from entering the premises such as clinical departments and hospital departments and offices unnecessarily.

#### **2. “Necessary entries” are considered as follows:**

- Entry by a graduate student (including international students) who is involved in education and research in the hospital or is a medical staff of the hospital
- Entry by a student (either undergraduate or graduate) who works in the hospital areas (full or part-time)
- Entry by a student who perform/participate in educational activities for clinical training

\*After finishing the above activities, please leave the premises immediately.

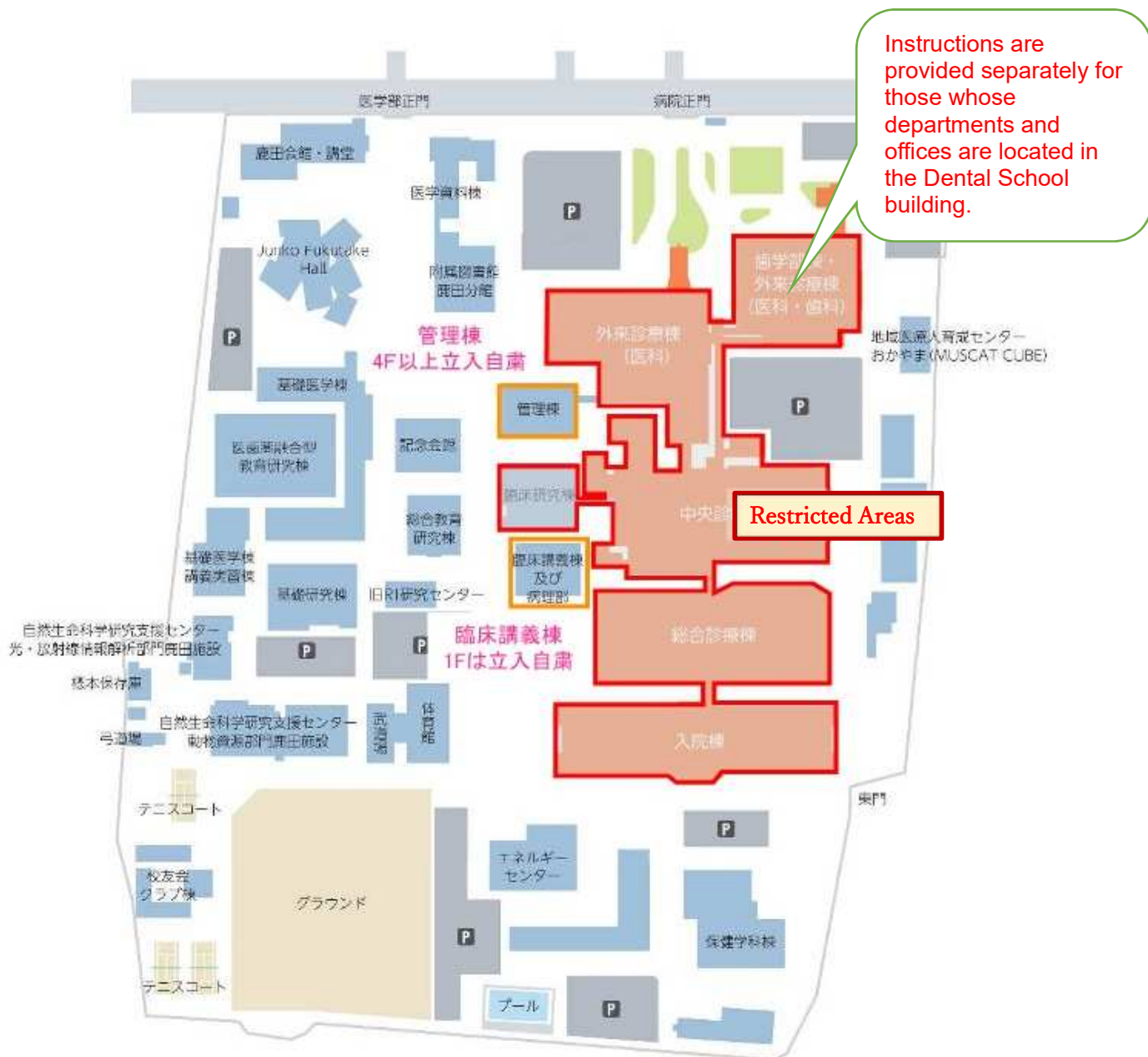

### Restricted Entry Areas in the Hospital



- **Restricted areas:**

Departments and offices on the 4<sup>th</sup> floor and above of the Administration Building, Clinical departments on the 1<sup>st</sup> floor of Clinical Education Building, and Hospital departments and offices.  
(Entry to clinical departments and hospital offices beside the above premises is also restricted)
